A fresh Postgraduate candidate is appointed as Assistant Professor after successfully going through the selection process and put on probation for a period of 2 Years. After the successful completion of probation period, he/she will be put on regular AICTE 6th pay of scale – AP1 Scale (Rs.15600/--Rs.39100/-). Once the candidate successfully completes a period of 5 years, he/she is put on AP2 scale(Rs.15600-Rs.39100/- with AGP Rs.6000/- – Rs.8000/-). If the candidate has good performance score as well as obtains NPTEL/ MOOC / Coursera etc. Certifications he/she shall be eligible to be put on AP3 Scale(Rs.37400/--Rs.44700/-).

If the candidate has enrolled for Ph.D. and has adequate research publication in refereed quality journals, he/she could be considered to be elevated as Associate Professor without AGP provided there are vacancies in their respective department. On completion of Ph.D. the candidates are put through a screening committee and based on recommendations of screening committee the candidates are liable to get a substantial financial benefit or a change in designation or both. If a candidate with 15+ year of experience and other prerequisite is put through screening come selection committee and elevated to the position of Professor & is given all the benefits as per AICTE Norms
